Must have achieved English and Maths level 2 and taken the test for English and Maths Level 2 if not achieved Building Documented evidence on Aptem to demonstrate knowledge and mastery of the occupation.

EPA – GATEWAY

Once the Employer is confident in occupational competence, the training provider (Storyy Training) will make sure that learner has attained the off the job hours and completed the programme attainment areas. The learner, employer and tutor will meet with the EPA Assessor and got through a gateway meeting to speak about the process of the EPA as well as resits and appeal process – You can find these policies and procedures within the resource centre – (tag) Storyy Training

Must have achieved English and Maths level 1 and taken the test for English and Maths Level 2 if not achieved Building Documented evidence through Reflective accounts to demonstrate knowledge and mastery of the occupation.

EPA - GATEWAY

Once the Employer is confident in occupational competence, the training provider (Storyy Training) will make sure that learner has attained the off the job hours and completed the programme attainment areas. The learner, employer and tutor will meet with the EPA Assessor and got through a gateway meeting to speak about the process of the EPA as well as resits and appeal process – You can find these policies and procedures within the resource centre – (tag) Storyy Training

- 1. At 18 months, the learner will go through Gateway with the EPA awarding body, at this point they will be given a work-based project title. Leaner will submit their draft for approval to the Assessor
- 2. Work based Project with Presentation with Q & A
- 3. Observation with Q & A
- 4. Panel Interview to go over the Knowledge Skills and Behaviours underpinned by evidence from portfolio
